**PROJECT** 

#### **Action Requested**

Adopt Resolution No. 23-01 approving an increase in SPRTA's funding allocation of Regional Transportation and Air Quality Mitigation Fee program (Tier I) funds for the Interstate Auxiliary Lanes project from \$10.4 million to a not to exceed \$15.4 million.

#### **Background**

The I-80 Auxiliary Lane project will add an eastbound auxiliary lane between SR 65 and Rocklin Road and a 5th westbound lane between Douglas Blvd and Riverside Avenue to relieve traffic congestion. On June 24, 2020, the SPRTA Board allocated \$0.4 million as specified in Authority Resolution No. 20-07. On March 23, 2022, the SPRTA Board allocated \$10 million for the construction phase of the project.

#### **Discussion**

Staff recommended today that the PCTPA Board conditionally approve entering into an amended Cooperative Agreement with Caltrans for the project's construction phase. The amended Cooperative Agreement requires an update to project cost and funding in response to the increased cost associated with the low bid to construct the project.

The I-80 Auxiliary Lane project's construction phase budget reflected in the March 2022 approved Construction Cooperative Agreement is \$32.133 million, including supplemental work, State furnished materials and expenses, and 5% project contingency. Funding commitments secured by PCTPA include SB1 SSCP and TCEP funds, locally controlled federal funds (Earmark Repurposing, STBG, HIP and Covid Relief funds), and SPRTA funds.

The Engineer's Estimate for the construction contract was \$28,478,676. Bids were received on January 26<sup>th</sup> and are valid for a 30-day period to February 26, 2023. The low bid was \$36,651,368. The budget needed to award to the lowest bidder is \$40,714,326, including supplemental work, State furnished materials and expenses, and 5% project contingency. The shortfall to award the project is \$8,581,326. The State

is responsible for \$2,473,488 of this shortfall. PCTPA is responsible for the remainder, which is proposed to be addressed through existing project reserve funds and a \$5 million increase in the SPRTA funding allocation. PCTPA's action is conditional subject to the SPRTA Board commitment to increase the project's funding commitment from \$10.4 million to an amount not to exceed \$15.4 million.

#### **Financial Analysis**

Staff analyzed the funding allocation request with currently programmed work allocations and determined there is sufficient anticipated revenue to allocate the requested funds.

#### Recommendation

Staff is recommending that the Board approve increasing SPRTA's funding allocation for the Interstate 80 Auxiliary Lanes project from \$10.4 million to an amount not to exceed \$15.4 million. Both the PCTPA and SPRTA Technical Advisory Committees concur with the staff recommendation.

# A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SOUTH PLACER REGIONAL TRANSPORTATION AUTHORITY APPROVING AN INCREASE IN THE CONSTRUCTION FUNDING ALLOCATION OF REGIONAL TRANSPORTATION AND AIR QUALITY MITIGATION PROGRAM FEES FOR THE I-80 AUXILIARY LANES PROJECT

The following resolution was duly passed by the Board of the South Placer Regional Transportation Authority at a regular meeting held February 22, 2023 by the following vote on roll call:

WHEREAS. the South Placer Regional Transportation Authority ("Authority") was formed

**WHEREAS**, the South Placer Regional Transportation Authority ("Authority") was formed to provide for the coordinated planning, design, financing, acquisition, determination of the timing of construction, and construction, of certain transportation improvements located in the area of jurisdiction of the Authority; and

**WHEREAS**, the I-80 Auxiliary Lanes project will construct an eastbound auxiliary lane between SR 65 and Rocklin Road and a 5th westbound lane between Douglas Boulevard and Riverside Avenue to relieve traffic congestion; and

**WHEREAS**, Placer County Transportation Planning Agency (PCTPA) is the lead agency for the I-80 Auxiliary Lanes project; and

WHEREAS, Caltrans will advertise, award and administer the construction contract; and

**WHEREAS**, on June 24, 2020, the Authority approved a design and right-of-way funding commitment not to exceed \$0.4 million as specified in Authority Resolution No. 20-07; and

**WHEREAS**, on March 23, 2022, the Authority approved a construction funding commitment not to exceed \$10 million as specified in Authority Resolution No. 22-04; and

**WHEREAS**, various federal and State funds have been previously secured by PCTPA to reduce the project funding needed from SPRTA's Tier I fee program; and

**WHEREAS**, the I-80 Auxiliary Lane project's construction budget reflected in the approved Construction Cooperative Agreement is \$32.133 million; and

WHEREAS, the budget needed to award to the project's lowest bidder is \$40,714,326,

leaving a shortfall to award the project at \$8,581,326 to be shared between the State and PCTPA; and

**WHEREAS**, PCTPA proposes to address the project funding shortfall through use of project reserve funds and a proposed increase in the SPRTA funding allocation; and

**WHEREAS**, PCTPA's action is conditional subject to the SPRTA Board commitment to increase the project's funding allocation from \$10.4 million to a not to exceed \$15.4 million; and

WHEREAS, PCTPA is requesting an additional \$5 million of Tier I funding for the project.

**NOW, THEREFORE, BE IT RESOLVED THAT** the Authority approves an increase in SPRTA's funding allocation of Regional Transportation and Air Quality Mitigation Fee program (Tier I) funds for the Interstate Auxiliary Lanes project from \$10.4 million to a not to exceed \$15.4 million.

### I-80 Auxiliary Lanes Bid Results - Funding Allocation Increase Request

Rick Carter provided two comparison SPRTA cash flow spreadsheets. One included the Rocklin Road Interchange with a project cost estimate of \$10 million, the currently approved allocation. The other included the Rocklin Road Interchange with a project cost allocation of \$23 million since the fee update contemplates this increase. If the SPRTA Board funds the I-80 Auxiliary Lanes shortfall of \$5 million, as is being requested, there is sufficient funding for the projects currently allocated in the SPRTA CIP. If the Rocklin Rd Interchange costs allocation is eventually increased to \$23 million and stays on a similar schedule we will have a negative cashflow for a few years. There was a clarifying discussion noting that today's request was limited to the \$5 million request for the I-80 Aux lanes project and there is the need to have future discussions regarding SPRTA project priorities and future allocations.

As explained in the PCTPA TAC meeting, the low bid for I-80 Auxiliary Lanes project left us with an approximate \$8.5 million shortfall of which PCTPA is responsible for approximately \$5 million. We will be asking the SPRTA Board to increase the project's funding commitment to a not to exceed amount of \$15 million (previously \$10 million). The TAC concurred with the recommendation.

#### Other Items

- Rick said that we will have a Closed Session Item for ROW negotiations for the Highway 49 Gap Closure Project.
- Matt said he'll be going to the Building Industry Association (BIA) on February 15<sup>th</sup> to brief them about the fee update. He welcomed others who wish to join him.
