Placer County Transportation Planning Agency (PCTPA) is in the process of updating the Placer County Regional Transportation Plan (RTP), known as the 2050 RTP, and has determined that the update is subject to the California Environmental Quality Act (CEQA). CEQA requires the preparation of an environmental impact report (EIR) prior to approving any project that may have a significant impact on the environment. PCTPA has a certified program-level EIR that was prepared for their existing RTP. They intend to prepare a supplemental EIR to evaluate new information and changes that have occurred since certification of the program-level EIR. It is noted that not all aspects of the future improvement projects are known at this stage in the planning process to enable detailed site specific analysis. Individual improvement projects that require further discretionary approvals when their project details become available will be examined in light of this EIR to determine whether additional environmental documentation must be prepared.

We need to know the views of your agency or organization as to the scope and content of the environmental information relevant to your agency's statutory responsibilities or of interest to your organization in connection with the proposed project. Specifically, we are requesting the following:

- 1. If you are a public agency, state if your agency will be a responsible or trustee agency for the project and list the permits or approvals from your agency that will be required for the project and its future actions;
- 2. Identify significant environmental effects and mitigation measures that you believe need to be explored in the EIR with supporting discussion of why you believe these effects may be significant;
- 3. Describe special studies and other information that you believe are necessary for PCTPA to analyze the significant environmental effects, alternatives, and mitigation measures you have identified;
- 4. For public agencies that provide infrastructure and public services, identify any facilities that must be provided (both on- and off-site) to provide services to the proposed project;

- 5. Indicate whether a member(s) from your agency would like to attend a scoping workshop/meeting for public agencies to discuss the scope and content of the EIR's environmental information;
- 6. Provide the name, title, email, and telephone number of the contact person from your agency or organization that we can contact regarding your comments;

The NOP will be available for review from February 12, 2025, through March 14, 2025. A hybrid in-person/virtual public scoping meeting will be held during the public review period on March 4, 2025, from 5:00pm-6:00pm. Interested parties may attend in person at PCTPA's offices at 2260 Douglas Blvd, Suite 130, Roseville, CA 95661 or virtually through this Microsoft Teams link. The meeting ID is: 299 920 357 690; Passcode: 7Wg3nz74. Due to the time limits mandated by State law, your response must be sent and received by PCTPA by March 14, 2025, at 5:00 pm.

If we do not receive a response from your agency or organization, we will presume that your agency or organization has no response to make. A responsible agency, trustee agency, or other public agency may request a meeting with PCTPA or its representatives in accordance with Section 15082(c) of the CEQA Guidelines.
